

ORDINANCE NO. 2-2022

AN ORDINANCE CORRECTING, NUNC PRO TUNC, ORDINANCE NO. 1-2022, DESIGNATING THE GRISWOLD URBAN REVITALIZATION AREA OF THE CITY OF GRISWOLD, IOWA

WHEREAS, the City Council has previously adopted Ordinance No. 1-2022 to designate the Griswold Urban Revitalization Area ("Area" or "Revitalization Area") as an urban revitalization area by ordinance; and

WHEREAS, prior to adoption of Ordinance No. 1-2022, the City Council had adopted Resolution No. 12-2022 adopting the Griswold Urban Revitalization Plan; and

WHEREAS, there was a scrivener's error in Ordinance No. 1-2022, identifying the incorrect resolution number for the resolution adopting the Griswold Urban Revitalization Plan, and this correcting ordinance is intended to correct said error "nunc pro tunc," meaning to make the correction retroactively effective as of the effective date of Ordinance No. 1-2022.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRISWOLD, IOWA:

Section 1. That the preambles of Ordinance No. 1-2022 referring to the resolution adopting the Griswold Urban Revitalization Plan are hereby corrected, nunc pro tunc, to delete "**Resolution No. 6-2022**" and substitute in place thereof the following: "**Resolution No. 12-2022**".

Section 1. That such action in amending Ordinance No. 1-2022 is hereby taken nunc pro tunc, meaning that although Ordinance No. 1-2022 is amended by this Ordinance, the effective date of Ordinance No. 1-2022 will remain the same; further, all other provisions of Ordinance No. 1-2022 not affected or otherwise revised by this Ordinance be and the same are hereby ratified, confirmed, and approved in all respects.

Section 2. That if any section, provision, or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance or any section, provision, or part thereof not adjudged invalid or unconstitutional.

Section 3. That all ordinances or parts of ordinances in conflict herewith be and the same are hereby repealed to the extent of such conflict.

Section 4. This Ordinance shall be in effect after its final passage, approval, and publication as provided by law.
