

CITY OF GRISWOLD, IOWA
ORDINANCE NO. 4-2022

AN ORDINANCE VACATING A PORTION OF THE EAST-WEST STREET
LOCATED BETWEEN LOTS 4 & 15 AND LOTS 5 & 14, ALL IN THE FOURTH
ADDITION TO THE TOWN OF GRISWOLD, IOWA

WHEREAS, pursuant to notice published in the manner required by law, on the 9th day of May, 2022, this Council held a public hearing on a proposal to vacate a certain portion of the public right of way as hereinafter described; and

WHEREAS, this Council determines that it is in the best interests of the City that said public alley way be vacated.

BE IT ENACTED by the City Council of the City of Griswold, Iowa:

SECTION 1. The City of Griswold, Iowa does hereby vacate and release the following-described public alley way:

All of the street running East and West in the Fourth Addition to the Town of Griswold, Iowa, in the original plat thereof, and specifically located between Lots 4, 15, 5 & 14 in said Fourth Addition.

SECTION 2. The North half of said street is conveyed and assigned to the adjoining Lots numbered 4 & 15; the South half of said street is conveyed and assigned to the adjoining Lots numbered 5 & 14.

SECTION 4. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION 5. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 6. WHEN EFFECTIVE. This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
