

ORDINANCE NO. 5-2022

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF GRISWOLD, IOWA, BY AMENDING SECTION 6-5-12 PERTAINING TO STORM WATER DRAINAGE MANAGEMENT RATE AND MANNER OF PAYMENT.

BE IT ENACTED by the City Council of the City of Griswold, Iowa:

SECTION 1. SECTIONS MODIFIED. Section 6-5-12 of the Code of Ordinances of the City of Griswold, Iowa, 2018, is repealed the following adopted in lieu thereof:

(Code of Iowa, Sec. 684.84(1))

6-5-12 STORM WATER DRAINAGE MANAGEMENT RATE AND MANNER OF PAYMENT. Each residential, commercial, industrial, and governmental user within the corporate limits of the City shall pay for storm and surface water drainage system service provided by the City, at the same time payment for City water and sewer is made, and shall be charged as follows:

- 1. Monthly rate of ~~\$3.00~~ \$10.00

SECTION 3. SEVERABILITY CLAUSE. If any section provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 3. WHEN EFFECTIVE. This ordinance shall be in full force and effect upon its passage and publication, as required by law.


